ELIGIBILITY & INFORMATION

1. **AGE CATEGORIES:**
U-11,U-13, U-15, U-18, U-21; born on or after Jan 1, 1994, 1992, 1990, 1987,1984 respectively; Seniors (40+), born before Jan 1, 1965; Senior (60+), born before Jan 1, 1945.
2. **TEAM EVENTS:**
Open Team: open to all players;
Team "A" : (U-1500 each, U-3000 combined.)
Team "B" : (U-750 each, U-1500 combined.)
Senior Team : at least 1 over 40, and 1 over 60.
3. **NOVICE EVENTS:**
Open to ALL players with rating U-250; previous finalists in Provincial Junior Events and winners of previous novice events are NOT eligible in same event. All novice events will be held in the small Gym. Players will enter novice event as one event and coach Wang will determine which group (A,B,C,D) the player belongs to based on their level except for adult novice. Adult Novice event is for players over 18 and with no rating. Servicing rules will NOT be enforced on novice events B,C and D.
4. Junior players must enter their OWN age group and any ONE higher group. Maximum number of events: 4 individual and 3 teams/dbls,and should not enter events with SAME starting time.
5. Latest available CTTA rating will be used at draw; evaluation of non-rated players is at the discretion of the Tournament Committee; latestITTF rules will govern all play for sanctioned events. All matches are 3/5, and 11 points for each game except Open Single's Semi-finals and finals, which are 4/7. This event will be used for the team trial and counts as points towards team selection.
6. Team Play Format (All team events are 2 players team); higher rating to higher rating, lower rating to lower rating and one double.
7. **EQUIPMENT:**
Stiga Elite/Expert Roller Tables; Stiga/Donic nets and 3-star orange balls.
8. **UMPIRES:**
Players required umpiring in round robin and the loser of elimination round umpiring the next round. The umpire is responsible to return the tournament ball and the match slip with the winner's signature on.
9. **DEFAULT:**
5 minutes late after the event is called will be defaulted. (please report your conflict to the control desk if you are still playing other events)
10. **ENTRY FEES:**
Team Events: \$15 per team.
Junior Novice Singles: \$3 per event.
Individual Events: \$6 per player per event, plus rating fees for sanctioned events.
