Eligibility of players in age categories must be:

- Junior
 - 11 & Under - born on or after January 1, 1994
 - 13 & Under - born on or after January 1, 1992
 - 15 & Under - born on or after January 1, 1990
 - 18 & Under - born on or after January 1, 1987
- Senior
 - Over 40—born in 1965 or earlier.
 - Over 50—born in 1955 or earlier..
- Mid Western Trials
 - 21 & Under – born on or after January 1, 1984

Tournament Rules

Start Times: The listed starting times are for guidance only. An event will not start prior to the time listed, but should start at that time or shortly thereafter, depending on the number of entries and as time allows. **DO NOT BE LATE, OR YOU MAY FACE DEFAULT.**

Rules: International Table Tennis Federation rules shall govern all play.

The tournament committee reserves the right to cancel any event with insufficient entries.

Membership Eligibility: All competitors must be in good standing and registered members of their Provincial Table Tennis Association or USTTA. Non-members or members whose current membership has expired must include the STTA membership fee, \$25.00 junior fee and \$30.00 senior fee with their entry fees.

EQUIPMENT: Butterfly Europa Tables and Orange Butterfly Three Star Balls.

Prizes: Trophies or medals for the winner and runner-up in all events.

Doors will be open at 8:00 am

Scoring: New Scoring system will be used all games to 11 points. Best of 5 for all singles events, except for Open Finals— best of 7.

EVENT LIMITATIONS

Players may only enter one event per start time

Ratings: Ratings from the most recent period will be used. Ratings can be obtained from the CTTA website at www.ctta.ca.

TOURNAMENT STRUCTURE

OPEN SINGLES: All players will be placed in a round robin and play each person in their pool. The top 2 from each pool will advance to the A/B side. The rest of the players will play in the C/D/E sections depending on the number of participants entered. The goal of this event is to maximize the number of matches played by each other.

AGE EVENTS: Players will be placed in round robin pools for qualifying in all events.
